### 2. Application file

Applications MUST include:

- A letter of expression of interest **specifying the position in the subject line** including the period of availability to start the mission, three professional references (email and telephone contact);
- A curriculum vitae.
- A copy of the highest degree.

#### **4. Selection Process**

Consultants will be selected according to the qualification-based selection method as defined in the ECOWAS Public Procurement Code. A skills and abilities assessment interview will be held with the best shortlisted candidates.

Only shortlisted applications will be contacted. With equal skills, female candidates will be privileged. The Pool Administration and Finance reserves the right not to follow up on this call for applications.

The ARAA reserves the right not to proceed with this call for applications.

#### **5. Conditions for the provision of services**

A consultant contract will be signed with the successful candidates for a period of three (3) months and with a fixed remuneration negotiated on the basis of experience and market conditions.
